Things to Remember

- Open year around to the public daily 8 am until sunset
- Available for rent 7 days a week. Reservation times are a 4 hour minimum.
- Reservations must be made in person between the hours of 8am and 4pm Monday –Friday
- \$25 dollar clean up/damage deposit
- Rental fees are \$40 resident/\$60 non-resident for either 8-2 or 2-sunset, or \$75 resident /\$113 non-resident for 8:00am-sunset
- All damage deposits and rental fees must be paid in full at the time of reservation of the Bass Lake picnic shelter. Reservations are not held without full payment.
- Processing Fee for rental amendments or schedule changes unless due to Town weather cancellations. Rentals must be rescheduled within 30 days of the original rental start date.
- Alcohol is not allowed at the shelter.
- The Bass Lake shelter is not to be used for weddings or receptions.
- May be rented up to six months in advance
- No same day rentals
- Ample time should be allowed for set up and clean up within your rental time. You must be cleaned up and ready to leave by the end of your rental time.
- Decorations may be affixed with push pins and staples but no tape is allowed.
- All trash must be disposed of properly in provided receptacles.
- Smoking is prohibited at Bass Lake Park.
- Personal grills are not permitted in the picnic shelter or parking lot.
- There are two stationary charcoal grills at the shelter.
- A pig cooker is allowed in the parking lot providing it is attended at all times and has a drip pan underneath to prevent damage to the parking lot surface. Staff should be notified if a pig cooker is going to be used.

- The Bass Lake shelter is limited to 40 occupants.
- Additional tables and seating are a violation of fire code and are not allowed along walkways or in the parking lot.
- Tables are stationary and do not move.
- Loud noises of any kind are prohibited. Amplified music or DJ's are not allowed.
- Inflatables are not allowed at the Bass Lake Shelter.
- Extension cords are not allowed in the picnic shelter.
- Canopies and tents are not allowed at the shelter or in the park at Bass Lake.
- Resident is defined as an individual or business that resides within the Municipal Town Limits of Holly Springs and pays Holly Springs taxes and/or utilities. Non-Residents may not use a Resident to obtain Resident Rates. Renter must be on-site for entire event.

Parking

The Bass Lake Park Picnic Shelter parking lot has twenty-nine (29) parking spaces with an additional two (2) handicap parking spaces near the Shelter itself. Proceed out of our lot, make a right onto Bass Lake Rd, and the second driveway on your right will be the Picnic Shelter.

Carpooling is always recommended as parking spots cannot be reserved during your rental.

Alcohol Policy and Information

Alcohol is not permitted at the Picnic Shelter.
